



Montreal Impact Foundation's 50/50 raffle – Official rules and important information

ADMISSIBILITY

- Participation is exclusively reserved to people aged 18 and over and physically located in the province of Quebec during the time of purchase.
- The following people are excluded from participating in the 50/50 raffle: volunteers and employees of the 50/50 draw working during games, the Foundation's employees and their immediate family, the employees of the Free 2 Play Information Technology Department assigned to the implementation of the raffles, the employees of the enterprise implementing the raffle's technology as well as the Foundation's board members.

HOW TO PARTICIPATE

- Ticket sales will take place online and at Stade Saputo; 4750 Sherbrooke East, Montreal, QC, via a platform administered by members of the Foundation.
- The participant will receive a printed coupon listing the numbers associated to the package purchased or a digital version of it with a payment receipt attached in the email. Each raffle number will be printed on an individual stub. These stubs will be inserted into a safe in a secure location at Stade Saputo to carry out the random draw and determine the winning number.
- Tickets are sold in packages of 1 for \$5; 3 for \$10; 15 for \$20 or 40 for \$40.
- Ticket sales start when the doors open and finish at the end of the game.

DRAW AND COMMUNICATING WITH THE WINNER

- The date of each draw will be announced at the beginning and during the time that tickets are on sale.
- Chances of winning depend on the total number of tickets sold.
- Tickets are subject to verification by 50/50 raffle organizers. Any fraudulent ticket will be automatically rejected and won't be considered for the prize.
- The draw will be carried out by an actual person when tickets stop being sold. This person will take three witnesses (done virtually if the situation asks for it) and choose a stub corresponding to a number sold.
- The raffle ends when the grand prize reaches \$10,000.
- The winning number will be announced and published on the Foundation's website. If the number announced and the official winning number do not match, the latter takes precedent.



- The amount to be won represents 50% of the total amount collected and announced (grand prize) and cannot exceed \$5,000 (CAD) per draw. If the number announced and the official winning number do not match, the latter takes precedent.
- The person whose ticket will be chosen will be contacted by phone and/or email once the draw is finished. The Montreal Impact Foundation assumes no responsibility regarding any person claiming an interest or right to receiving the entirety or a part of the prize associated to the winning number.
- If the winner does not claim his prize within two business days, a new draw will be carried out the following day. The new winner will be contacted by phone and/or email once the new draw is finished.
- The winner will need to provide two pieces of identification and fill out a declaration and exoneration of responsibility before claiming their prize.
- The prize will be submitted via e-transfer in Canadian dollars following the reception of information.

OTHER GENERAL CONDITIONS

If our electronic system undergoes major technical difficulties during a raffle (at any time after tickets start being sold), the sale of 50/50 raffle tickets will be halted immediately and will only proceed once the problem is resolved, and only if the solution is found in time for ticket sales to continue according to the conditions listed below.

If ticket sales cannot proceed at a later time, the Montreal Impact Foundation is able to verify that each ticket purchased before the suspension of sales were treated, and if so, the random draw will take place and a winner will be announced. If the Montreal Impact Foundation is unable to verify if tickets purchased before the suspension of ticket sales were treated correctly, the random draw will be postponed to a time indicated on the Foundation's website (fondation.impactmontreal.com) and on CF Montréal's social media accounts. This established time may be modified if needed until the Foundation is able to carry out its verification. If a draw is postponed, the Montreal Impact Foundation will announce a winner as soon as possible and will publish the winning number as indicated below.

- The Montreal Impact Foundation, Free 2 Play, Stade Saputo, and every sponsor and partner of the 50/50 raffle administer in good faith and in the best interests of the Foundation. No partner (or employee or representative of these entities) is liable at any time for any errors, system malfunctions, or decisions made related to the management of the program.
- No official receipt will be emitted for tax purposes when purchasing a 50/50 raffle ticket as determined by the Canada Revenue Agency.
- The 50/50 raffle is subject to all applicable federal, provincial and municipal laws and regulations. All decisions made by the organizers are final.



RELEASE PUBLIC STATEMENT

- The winners release the Foundation, its advertising and promotional agencies, their employees, agents and representatives from any liability for any damage they may suffer as a result of the acceptance or use of the prize.
- By participating in this 50/50 raffle, the winners authorize the organizers and their representatives to print, publish or use their name, image, photo, voice, likeness, and biographical information for any reason, including, but not limited to, advertising purposes, without financial compensation, except when prohibited by law
